

Local Rules from 23/11/2021

OUT OF BOUNDS.	<ul style="list-style-type: none"> • ALL AREAS BEYOND THE COURSE BOUNDARY AND ANY LINE OF WHITE STAKES WITH BLACK TOPS. • THE GREENKEEPERS COMPOUND. • ALL AREAS BEYOND THE CART PATH SURROUNDING THE CLUBHOUSE INCLUDING THE GARDENS.
INTERNAL OUT OF BOUNDS – HOLE 10	<p>When looking down hole 10 from the 10th tee, OOB stakes have been placed along the left side of the tree line that separates the 10th and 13th hole. The area left of these stakes, when playing the 10th, is considered Out of Bounds. The internal boundary is defined by white stakes with black tops. When playing the 13th hole, NO INTERNAL OUT OF BOUNDS APPLIES. The OOB stakes are treated as immovable obstructions and free relief is granted. Deliberately altering or removing these stakes during the play of any hole, will incur a General Penalty.</p>
NO PLAY ZONES.	<p>Within one (1) club length of any tree in the general area which has a stake, surrounding protection, support wires or poles, or the tree defined by this local rule interferes with the player's stance or intended swing.</p> <ul style="list-style-type: none"> • Relief from No Play Zones defined by this local rule <u>MUST</u> be taken in accordance with Rule 16.1b
GROUND UNDER REPAIR	<p>G.U.R is defined by white stakes and/or lines. Relief may be taken in accordance with Rule 16.1 relevant clauses. For bunkers declared as G.U.R a single stake or sign may be used. If a bunker is declared GUR, the whole bunker will be G.U.R.</p>
PENALTY AREAS.	<ul style="list-style-type: none"> • All areas defined by YELLOW stakes, imbedded markers and or lines. • All areas defined by RED stakes, imbedded markers and or lines. <p>Note: Copper logs bordering penalty areas are IMMOVABLE OBSTRUCTIONS and are in the penalty area, relief as per Rule 16.1b <u>ONLY</u> if ball is outside of the penalty area.</p>
POWER LINES AND POLES.	<p>A ball striking overhead power lines or supporting poles on the course while playing the 15th, 8th or 6th holes <u>MUST</u> be replayed without penalty in accordance with Rule 14.6.</p>
CAMERA INSTALLATIONS	<p>Whilst playing the 10th hole , if a ball strikes the camera installation on the 10th hole, the stroke is cancelled and <u>MUST</u> be replayed without penalty in accordance with Rule 14.6</p>
CAMERA INSTALLATIONS	<p>Camera installations on the course are defined as Obstructions. Relief in accordance with Rule 16.1b may be taken.</p> <p>In addition, If the ball lies within the <u>line of sight</u> corridor, relief may be taken in accordance with Rule 16.1b. <u>The Line of Sight Corridor</u> extends behind the Camera Installation and 2 club lengths either side on a line that extends directly from the camera installation to the hole.</p>
FIXED SPRINKLER HEADS.	<p>All fixed sprinkler heads are Immovable Obstructions and relief may be taken in accordance with rule 16-1b.</p> <p>In addition, if a ball lies outside a bunker or penalty area and is within two club lengths of a sprinkler head which is within two club lengths from the green and the sprinkler head interferes with the line of play between the ball and the hole, relief may be obtained without penalty by dropping the ball at the nearest point not nearer the hole, that avoids the interference.</p>
GAZEBO'S ON THE COURSE.	<p>All gazebo's and surrounding gardens located on the course are Immovable Obstructions. If the obstruction interferes with the players stance or swing, Relief can be obtained in accordance with Rule 16.1b</p>
EXPOSED TREE ROOTS IN THE GENERAL AREA	<p>If an exposed tree root in the general area is within two club lengths of or on the defined fairway and interferes with a player's intended stroke, relief may be taken in accordance with Rule 16.1b. Interference to a player's stance is not considered interference under this local rule.</p>
GARDENS.	<p>All gardens unless otherwise defined are an integral part of the course.</p>
OTHERS:	<p>Shoes with Metal Spikes are not permitted on the course or in the Club House</p>
